## TSN 1200 ULTIMATE SEASON SEATS PACKAGE CONTEST OFFICIAL RULES AND REGULATIONS

(the "Rules")

- 1. The TSN 1200 Ultimate Season Seats Sports Package (the "Contest") starts at 7:05 a.m. ET on Monday, April 8<sup>th</sup>, 2019 and ends on Friday, April 26<sup>th</sup>, 2019 at 5:05 p.m. ET. No purchase necessary. Void where prohibited.
- 2. The Contest sponsor is TSN 1200 Radio, a division of Bell Media Inc. (hereinafter referred to as the "Contest Sponsor").
- 3. To enter and to be eligible to win, entrant must be a legal resident of Ontario, Canada and be eighteen (18) years of age or older. Employees of Bell Media Inc., its agents, parent, affiliated or related companies, subsidiaries, divisions, prize sponsors, promotional and advertising agencies or of any other entity involved in the development, production, administration, or fulfillment of the Contest, as well as the parents, siblings and children of any such employees and any person domiciled with such employees, are ineligible to enter. In the event the entrant is outside of the local calling area, standard long distance rates as charged by the entrant's long distance service provider will apply. The twenty-fifth (25th) caller through on the Contest line following an Announcement will be eligible for entry into the Prize Draw as described below (an "Eligible Draw Entrant"). Each Eligible Draw Entrant will be announced on-air and may be required to chat on-air. Approximate retail value of the Prize is twenty five thousand dollars (\$25,000.00) CAD.
- 6. Prize must be accepted as awarded. The Prize may not be sold, transferred and is not convertible to cash. Contest Sponsor reserves the right to substitute a Prize in whole or in part in the event that all or

- any component of the Prize is unavailable. The tickets are subject to the terms and conditions of the issuing company. The choice and location of the tickets are at the sole discretion of the Contest Sponsor. Prize winner is solely responsible for all costs not expressly described herein.
- 7. On April 29<sup>th</sup> 2019, at approximately 8:35 a.m. ET, a random draw for the Prize will take place at Bell Media Inc., Ottawa, Ontario from among all Eligible Draw Entrants. The first Eligible Draw Entrant drawn will be eligible to win the Prize. The odds of winning the Prize from among the Eligible Draw Entrants are one in one hundred and twenty.
